RULES OF PROCEDURE

In the interest of all our customers, we kindly ask you to observe the following points:

1) ADMISSION AND RESIDENCE CONDITIONS

Any person wishing to enter or stay at the campsite must first report to the reception.

The fact of staying at the campsite implies acceptance of the provisions of these rules and the commitment to comply with them.

All participants who are subject to the sanitary pass requirement must present it upon arrival.

All contracting parties must be older 18 years old.

Minors must be accompanied by their parents or legal guardians for the duration of the stay.

2) WEARING THE BRACELET

The non-transferable wristband must be worn by all guests staying at the campsite as soon as they arrived.

3) INSTALLATION

<u>Pitches</u>: The outdoor facility and related equipment must be installed on the specified site in accordance with the instructions given by the manager or his representative.

Accommodation: Guests will stay on the indicated location according to the instructions given by the manager or his representative. Any additional installation (e.g. tent) is forbidden on the rental sites.

Everyone is responsible for the good appearance and the cleanliness of their pitch. The pitch must be left clean on the day of your departure. If the accommodation or pitch has not been cleaned before your departure, a cleaning fee will be charged.

4) MAINTENANCE AND APPEARANCE OF FACILITIES

Everyone is obliged to refrain from any action that could harm the cleanliness, hygiene and appearance of the campsite and its facilities, especially sanitary facilities.

It is forbidden to throw waste water on the ground or into in the gutters. Facilities are provided for this purpose.

Household garbage, waste of any kind, papers, etc. must be deposited in the appropriate containers, papers, must be deposited in the various selective sorting containers accessible at the exit of the campsite.

Plantations and floral decorations must be respected. It is forbidden to plant tent peg / nails in trees, to cut branches, to make plantations.

It is not permitted to mark out the location of a facility by personal means, nor to dig up the ground.

Any damage to the vegetation, fences, grounds or facilities of the campsite will be charged to the person responsible.

5) NOISE AND SILENCE

Each tenant is responsible for any disturbance caused by people staying with or visiting him/her. It is requested to avoid any noise and discussions that could disturb the neighbours. Sound equipment must be adjusted accordingly, doors must be closed as quietly as possible.

There should be complete silence between 11pm and 7am.

6) CIRCULATION IN THE CAMPSITE

Only vehicles belonging to campers staying at the campsite are allowed to drive on the campsite.

Traffic in the campsite is limited to 6mph.

The entrance gates are closed at 11 p.m. and no cars or motorbikes are allowed on the campsite from 11 p.m. to 7 a.m. Vehicles are parked in the car park at the campsite entrance.

7) PETS

Animals are not allowed on the campsite.

8) VISITORS

Any holidaymaker receiving visitors during the day is required to report them to the reception and pay the appropriate fee (6€ per person for access to the aquatic area).

Visitors' cars are not allowed to enter the campsite.

9) AQUATIC AREA

Children under 12 years old must be accompanied by their parents or legal representative to access the pool. Please follow the health and safety instructions posted at the entrance to the pool.

Deckchairs and sunbeds are not subject to reservation. Swimming shorts are allowed.

10) GAMES

No violent or disruptive games may be organised.

Children must remain under the supervision of their parents or legal representatives.

11) SÉCURITY

a) Fire

Open fires (wood, charcoal, etc.) as well as electrical equipment (barbecue and plancha) are strictly forbidden.

Stoves must be kept in good working order and not be used in dangerous conditions.

Fire extinguishers in the park are available to everyone.

In case of fire, please inform the direction immediately before heading to the meeting point located in the parking lot in front of the reception.

b) Theft

All personal belongings (bicycle, etc) remain the responsibility of the camper throughout their stay. The campsite declines all responsibility in case of incidents falling under the civil responsibility of the camper. Although security is provided during the high season, campers are advised to take the usual precautions to safeguard their equipment.

12) DEPARTURE ARRANGEMENTS AND TOURIST TAX

Guests are asked to inform the reception desk of their departure the day before.

Tourist tax are paid at the reception desk, they are due according to the number of nights spent on the site.

Their amount is different from one municipality to another (0.66€ per night and per person from 18 years old).

Any undeclared supplement (extra person, ..) discovered during the stay will be charged to the client from the date of arrival.

13) INFRINGEMENT OF THE RULES OF PROCEDURE

In the event that a holidaymaker disrupts the stay of other users or does not respect the provisions of these rules, the manager or his representative may, verbally or in writing, if he deems it necessary, give formal notice to the latter to cease the disturbance.

In the event of serious or repeated infringement of the rules of procedure and after formal notice by the manager to comply with them, the latter may terminate the contract.

In the event of a criminal offence, the manager may call in the police.
